**Reviewed and Approved November, 2004 minutes**

**Treasurer**

- Most Recent financial statements were reviewed and approved
- 2004 Tax items sent to the CPA (Joelyn Carr-Fingerle) for processing
- Discussion of delinquent homeowner dues

**ACC committee**

- location of loud wind chimes seems to be from home(s) on Buckingham (actually at 34 SH)
- remind owners that dogs are not allowed to remain on decks
- home inspections will be carried out in late March or early April

**Landscape committee**

- three projects were discussed:
  - retaining wall downhill from 20-28 Schooner Hill has been completed; was paid from 2004 operating budget
  - an investigatory project to identify problems with the retaining wall adjacent to 7 Schooner Hill was approved, to be paid from 2005 operating budget
  - the area above the guest parking area on Schooner Hill is approved (Cleary #18449). Total cost is \$25,000 and will be paid from landscape enhancements in the 2005 operating budget.

**Streets & Lights committee**

- Status of EBMUD repairs was discussed
  - agreed that EBMUD has done a very good job of making repairs with a minimum of noise and inconvenience
- Agreed that special rules and regulations regarding vehicular traffic will be adopted and put in place for the days when streets are under repair.
  - rules will include **substantial fines** for violations of both parking and driving on the new slurry
  - Slurry to take place in late April or early May

**Parking committee**

- Discuss continuing parking rules violations of a few neighbors.
  - 3 Schooner Hill
  - 65 Schooner Hill
  - 72 Schooner Hill
- Agreement on fining and towing actions:
  - to include suggestions for temporary/permanent signage near the problem area at the end of Schooner before fining and towing commences now that the street repairs are over
  - should include the understanding of the number to call to retrieve the towed car
  - Proposed scenario would be as follows:
    - step one would be putting up the fine and towing notice
    - step two would then be the towing of culprit vehicles
  - How do you identify the car with the individual to be fined?
