The Towering Inferno

Summer is here. That means a lot of outdoor barbecuing. Residents of Hiller Highlands may be a bit more paranoid than most about the potential hazards involved with open flame cooking and request that everyone exercise extreme caution when they barbecue. If you use charcoal grills, please use a safe alternative to charcoal lighter fluid. In addition to its potential fire hazard (and it is fun to hear the “whoosh” when the lighter fluid ignites but that whoosh can also be the sound of disaster) charcoal lighter fluids are made from toxic petroleum distillates that produce VOC's which contribute to

ozone pollution (cough cough.) Alternatives include charcoal chimney starter devices and electric charcoal starters. I hear that some people even find dryer lint a great charcoal starter. Talk about recycling! If you try using dryer lint please let us know how it works so we can let all of your neighbors know. If you use a gas grill please store your extra gas canisters far away from your grill. Most importantly, don't leave your grills unattended while you are cooking and keep a fire extinguisher nearby.

Cider House Rules

The rules and regulations of Hiller Highlands IV apply to all who live here, renters and owners alike. If you are a landlord, you are responsible for the acts of your tenants and will be responsible for any penalties and assessments incurred as a result of your tenants' behavior. Landlords may want to highlight some of the rules and regulations in their lease agreements in order to avoid misunderstandings. If you are a resident owner you should already know the rules as they were provided to you before you purchased here. You can always check the CC&R's and other governing documents on the HHIV web site: www.HHIV.org.

Speed Racer

The roads in Hiller Highlands IV (except for Charing Cross) are private. The first two vehicles belonging to any "resident" ("resident" includes all the occupants of the residence) must be parked in the garage. If the resident has more than two vehicles a third vehicle can be parked in the driveway. Parking on a private HHIV street for more than five hours in any 24 hour period is not permitted. If a resident has more than three vehicles the extra vehicles must be parked outside of HHIV (for example on public roads such as Hiller Drive, Charing Cross and Grandview.) Residents cannot park in the guest parking area between 49 and 57 Schooner Hill. Guests of residents may park in guest parking for a maximum of 72 hours even if that guest has been Driving Miss Daisy.

MARLEY AND ME

We love our pets. Indeed, the average dog is a nicer person than the average person (Andy Rooney.) However, we do have rules applicable to pets in HHIV. The maximum number of pets permitted per residence is two. No one can keep an animal that habitually howls, barks or

disturbs the peace even if it My Dog Skip or Lassie herself. Pets may not be left unattended on exterior decks or patios. An animal's owner is responsible for removing and disposing of their pet's waste. To keep it green, keep it clean. Even though they may have been Born Free animals must be leashed when on HHIV streets.

The Money Pit

All visible changes to the exterior of the residence must be approved by the ACC (George Innes) before the changes are implemented. These changes include change of paint color and of the entryway door, installation of a satellite dish and installation of awnings.

Architectural Control Committee ("ACC") – George Innes

ACC Walk Around

The ACC does an annual "walk around" inspection of the exterior of homes in HH IV. This should be completed in the August - September time frame. Owners will receive a letter reflecting a list of any corrective action items noted during the inspection or indicating everything's OK.

HH IV Architectural Rules – Update

Periodically, rules issued by the Association are reviewed, updated and restated. For the Architectural Rules, we had to, among other things, include the Solar Rules that were adopted last year. We've also reorganized the document and added detail or clarification as appropriate to make it more useful. After approval in principle by the Board of Directors, the document will be distributed later this year to the member-

ship for a 30 day comment period, before final Board adoption.

Landscaping – Barbara Schindler

The Oakland Fire Department has just completed their annual inspection of units for fire safety issues – If you received a Management Vegetation Inspection Report that indicates “action is required”, please put a copy in my mailbox at 1 Schooner Hill so I can have the Cleary crew address the issue(s).

As the weather warms the irrigation system operating hours are of course being extended – please let me know if you notice or hear a leak in the irrigation system.

Parking area “bumpers” have been installed in the guest parking area to prevent further damage to plants.

Routine maintenance and replacement of plants continues.

Repair of the damaged planter in front of 6 & 8 Clipper Hill has been completed, we will shortly repair “rotted” boards on the other planters along Schooner Hill.

CORE – Pauly & Tom Langguth

This summer the HHIV Emergency Boxes will be cleaned and inventoried. Some supplies will need to be replaced due to age and some will need to be updated or upgraded. Information to assist you in preparing for emergencies (fire, earthquake, severe storms, power outages, etc.) will continue to be distributed on a regular basis. We are fortunate to have both Hiller High Notes and our own Hiller IV Bulletin; please take the time to read these when they arrive.

In our next Bulletin you will find a CORE Data Sheet to complete and return. We hope that everyone realizes how important this information would be during a major disaster. It will be neighbors helping neighbors and not the police or fire department that will be responding first.

Have a great summer but don't forget IT'S FIRE SEASON!

If you are interested, there will be a fire hose training session on Spyglass Hill from 9 to 11am on August 22nd; let me know if you want more information. Fire hoses are part of the equipment in the Emergency Boxes.

Caldecott Tunnel Fourth Bore – John Eastman

I am a founding member and past Secretary of the California incorporated NPO Caldecott Tunnel Fourth Bore Coalition, Inc. (FBC). The FBC includes six community organizations: Claremont Elmwood Neighborhood Association (CENA), East Bay Bicycle Coalition (EBBC), Friends of Temescal Rockridge Greenbelt (FROG), North Hills Phoenix Association (NHPA), Parkwoods Community Association (CPA) and Rockridge Community Planning Council (RCPC).

Caldecott Improvement Project Caltrans started advertising the Caldecott Improvement Project on May 18 and expects to open contractors' bids this August. Construction is slated to begin in Fall 2009. This \$450 M project on the north side of Highway 24 includes an on-site cement plant, a 40-ft high sound wall to shield the ground floors of Parkwoods Condominiums, and 24/7 tunnel drilling. Two related projects are also moving forward:

- **Kay Street Improvement Project.** This project, which will install a right hand turn lane from Caldecott Lane onto the Kay overcrossing and a signal light at Kay/Broadway, will start in October 2009. Its target completion date is mid 2010. (Kay Street is the overpass that connects Caldecott Lane with the North Oakland Sports Field.)
- **Realignment of Tunnel Rd. Off-Ramp.** Construction of the realigned off-ramp at the west end of the tunnel is scheduled to begin in November, with completion during late third quarter 2010.

Stakeholders Meetings. Caltrans has settlement agreements with the City of Oakland and the FBC. FBC plans to meet with Wlad Wlasowsky, Oakland City lead person, in order to monitor compliance of the City with its \$8M

agreement for mitigations. This agreement includes completion of sidewalks on Tunnel Road and Caldecott Lane, a crosswalk at the end of the the Warren Freeway, and a prohibition of overnight off-hauling of tunnel spoils that was negotiated by Council President Jane Brunner, among many other compensating benefits. Also, FBC will meet with Berkeley's transportation division to discuss cost findings and priorities for mitigation funds on the Hwy 13 section in Berkeley, the \$ 2 M funds provided via the FBC settlement, including proposals for sidewalk improvements along Tunnel Road, and a pedestrian-activated crossing at The Uplands. Also obtained via the FBC agreements, the Oakland Unified School District has received the \$3 M for air-filtration and landscaping improvements at Chabot Primary and Claremont Middle Schools.

The Caltrans Project Information Officer Jeff Weiss plans to meet soon with the FBC and other stakeholders in the tunnel and related projects. The purpose of the meeting will be to brainstorm best methods of communications with the public and stakeholder groups. FBC has asked Caltrans to discuss the traffic management plan, schedule, restrictions on parking, fire prevention measures, and complaint procedures. Stakeholder groups include, besides FBC members - Montclair Safety Improvement Council, Grizzly Peak Homeowners Association, Oakland Fire Assessment Citizen's Advisory Committee, North Hills Landscape Committee, Jack London Youth Soccer League, and Oakland Little League. Representatives from the Oakland Unified School District, Oakland Public Works Administration, and Council President Jane Brunner may also attend.

Specific items to be discussed may include - present a large blow-up map of the area so stakeholders can show the area they represent as well as for illustrative purposes during the discussions; push the information regarding construction events (blasting, detours, road closures, etc.) to the stakeholders via a listserve or other method as well as posting information on the project website; post roadside information signs for drivers/bicyclists; implement a complaint system that enables people to report issues by phone and online (There should be a numerical tracking system for complaints, and the complaints and resolutions should be pub-

lic.); post signs near the worksite with phone numbers for people to call, to accommodate people who are not on email; hold quarterly community meetings with stakeholder groups.
